- **Must have at least 20 years of Satisfactory Service**
 - Check your PCARS
 - This shows 19 years of service (as of 22 May 2020)
 - This and Last R/R Year Points Earned updates about 60 days after the close out of the R/R year
 - Must have 50 points to qualify for a “good year” toward retirement
- **Can retire after 15 years with certain medical codes**



Reserve Retirement: Officers

- **Must retire by your Mandatory Separation Date (MSD)**
- **MSD is whichever of these two is earlier**
 - The first day of the first month after you turn 60 years old (SECAF waiver needed to exceed age 60)
- **OR**
- **Based on rank (includes time on the IRR) – COMMISSIONED time ... prior enlisted time doesn't count toward these limits**
 - Lt Col – 28 years
 - Col – 30 years
 - Brig Gen – 30 years and 30 days
 - Major/Lt Gen – 35 years and 30 days
- **Must have 10 years of commissioned service to retire as an officer**
- **To receive pay based on your last rank**
 - Lt Col and above must serve in the rank for 3 years
 - Majors and below must serve in the rank for 6 months



U.S. AIR FORCE

Reserve Retirement: Enlisted

- **Must retire by your High Year Tenure date (HYT)**

- Can be found on vMPF > Service History

- **HYT is whichever of these is earlier**

- The first day of the first month after you turn 60 years old

OR

- The first day of the first month after hitting 33 Years of creditable service

- **You will receive retirement pay based on the last rank held**
- **Retirement order and ID will show Highest Grade Held (HGH)**
 - HGH determined at HQ ARPC

- **Voluntary Retirement:**
 - **Start the vPC application can be started up to a year before the requested retirement date**
 - **If within 30 days of the requested retirement date, written request must be routed through your detachment**


- **Involuntary Retirement:**
 - **Happens automatically when you hit your HYT or MSD**
 - **Takes roughly 90-120 days for the retirement to process**

Qualifying for Active Duty Retirement

- There is no magic points total
- Must accrue 20 years of Total Active Federal Military Service (TAFMS)
 - Time on AD plus time on orders that add
 - AT/IDTs don't count
 - vMPF>Self-Service Actions>Record Review>Service
 - Shown in Years, Months, Days (5 years, 4 months, 11 days)
 - Cumulative
- Include in your application
 - DD Form 2656 – banking/retirement pay
 - Any current orders that will take you to/past your retirement date
 - Terminal leave
 - Permissive Leave
 - Out-processing/TMO
 - Ceremony Date

Active Duty Retirement

- **Headquarters assigned with 20 years TAFMS apply through HQ AFPC**
- **Everyone else apply through the vPC Action Request**
- **Officers – Time in Grade requirement**
 - **Voluntary Retirement**
 - **Major and below - 6 months active duty service**
 - **Lt Col and above - 3 years active duty service**
 - **Involuntary Separation**
 - **MSD or involuntary separation from AD**
 - **All officers - 6 months active duty service**



What about sanctuary?

- **What is sanctuary?**

- Law that states those who attains 18, but less than 20, years of service must remain on active duty unless they voluntarily separate, medically disqualified for continued service, or is separated or discharged for cause
- Designed to protect the member from being “forced out” before earning retirement
- **Not used to keep a member from earning a reserve or active duty retirement**
- Prompts a “sanctuary waiver” when going on orders during this time
 - Member waives the right to claim sanctuary while on those orders
 - You’ll work the number of days of the orders and not force the unit to keep you longer

- **Reserve Sanctuary**

- Occurs when the member is between 18 and 20 “good years” toward a reserve retirement

- **Active duty sanctuary**

- Occurs when the member is between 18 and 20 years of TAFMS



Reduced Retired Pay Age

- **Age at which retirement pay starts is reduced by three months for each cumulative 90 days of qualifying active duty performed within a fiscal year**
 - **Prior active duty time, Annual Tour, AGR doesn't count**
 - **MPA, RPA, some school tours count**
- **Qualifying active duty may be combined between consecutive fiscal years**
 - **Effective date of the law was Jan 29, 2008**
 - **Not retroactive (doesn't count for time prior to 2008)**
- **Lowest it can be reduced is age 50**
- **Submit vPC application no less than 6 months prior to retirement**
 - **DO NOT NEED TO SUBMIT ORDERS**
- **Be sure to keep track of all your participation for proper credit**
- **Don't wait to be contacted, use the online application, if you think you have eligible service, especially if you believe you are nearing pay age**

- **QUALIFYING:** Has been reviewed and calculated
- **POTENTIALLY QUALIFYING:** Duty type is qualifying, but it hasn't yet been reviewed or calculated

Applying for Retirement

- **Apply as early as one year prior to your projected retirement date**
- **Retirement orders won't be cut until:**
 - **You've earned 50 points for your 20th R/R year**
 - **Any orders you're currently serving are over**
 - **If you're still accruing points, the retirement calculations can't be finalized**
- **Retirement date has to be AFTER the close out of your 20th R/R year**
- **If you had a bad year or sat on the IRR, that time won't count toward**
WHEN you're eligible to retire

Even though you are not required to apply for retirement, it is recommended you do so to ensure the Retirement application is completed in the retirement process. Please review Section 2 and select the Retirement Type that best fits your situation. For your convenience, your HSD or HYYT date is available to you in the application. If your retirement effective date is the same as your HSD or HYYT, please [click here](#) to provide information for your retirement ceremony and certificate.

Section 2 - Retirement Information/How to Apply Application Checklist

The basic retirement categories for Air Force Reserve and Air National Guard personnel are as follows:

Reserve Retirement:

 - You are eligible for Assignment or Transfer to the Retired Reserve if you have 20 satisfactory years of service. Reference [AFI 36-2503](#), Service Retirement and [AFI 36-2503](#), Separation and Retirement Procedures for Air National Guard and Reserve Personnel Members. In addition to preserving your retired pay entitlement, it is required as proof of service for space available based on military credit/ LHM DD Form 1304, Air Transportation Eligibility. You may submit a request on line using the vWP application at: [https://gum.cda.af.mil/retiredreserve.asp](#) or call 1-800-345-2263.
 - Please safeguard the 20 Year Letter. In addition to preserving your retired pay entitlement, it is required as proof of service for space available based on military credit/ LHM DD Form 1304, Air Transportation Eligibility. You may submit a request on line using the vWP application at: [https://gum.cda.af.mil/retiredreserve.asp](#) or call 1-800-345-2263.
 - Verify total number of retirement points to determine your basic eligibility for the Retired Reserve. In vWP, click on "Personal Data," then "JAGC/USAF Point Credit Summary Inquiry (PCMSI)" and "Point Summary" which will provide you with your total Satisfactory Service, and then click on "Service History" and at the bottom of the Retiree column this will provide your "Retired Points."
 - One more item you may want to check regarding on your date is to review our "Entitlements" information concerning the Reserve Component Survivor Benefit Program and the retirement pay calculation. You can access this information at [https://gum.cda.af.mil/retiredreserve.asp](#) or call 1-800-345-2263.

Active Duty Military Retirement:

 - To be eligible for an active duty military retirement, members must have accumulated 20 years of Total Active Duty Military Service (TAMSD) in the Retired Reserve. In vWP, click on "Personal Data," then "JAGC/USAF Point Credit Summary Inquiry (PCMSI)" and "Point Summary" which will provide you with your total Satisfactory Service, and then click on "Service History" and at the bottom of the Retiree column this will provide your "Retired Points."
 - One more item you may want to check regarding on your date is to review our "Entitlements" information concerning the Reserve Component Survivor Benefit Program and the retirement pay calculation. You can access this information at [https://gum.cda.af.mil/retiredreserve.asp](#) or call 1-800-345-2263.

Pay and Reduced Retired Pay Age (ARR)

 - You are approaching your 50th birthday and eligible to request your Retired Pay. You may submit an application up to 1 Year prior to your 50th birthday. In the application, your Requested Retirement Date should be your 50th birthday.
 - If you are currently participating in the Air Force Reserve or Air National Guard please be aware your orders and pay request will be delayed until all your points have been posted and an audit of your record has been completed. If you are in a Retired Reserve status, your application will not be reviewed any sooner than 4 months from your 50th birthday.
 - You will need to attach a DD Form 2556 to your application for processing. You will not be able to submit your application without it.
 - You may send your vWP application to complete at a later date once you have submitted a requested retirement date.

Pay and Reduced Retired Pay Age (ARR)

 - You are approaching your confirmed Reduced Retired Pay Age (RRPA) and are eligible to request your Retired Pay. You may submit an application up to 1 Year prior to your RRPA. In the application, your Requested Retirement Date should be your confirmed RRPA or later.
 - If you are unsure what your confirmed RRPA is, please click and click on the worksheet screen. Please change the View button you put down "Submitted my vWP." Then you will be able to see an audit of your record has been completed the year to 2025. Finally, click on refresh and your submitted RRPA application should be available to you.
 - If you are currently participating in the Air Force Reserve or Air National Guard please be aware your orders and pay request will be delayed until all your points have been posted and an audit of your record has been completed.
 - If you are in a Retired Reserve status, your application will not be reviewed any sooner than 4 months from your 50th birthday.
 - You will need to attach a DD Form 2556 to your application for processing. You will not be able to submit your application without it.
 - If you have not submitted a RRPA application, you will need to go to the Action Request box and under the Retirement menu you will find the Reduced Retired Pay Age application.

Section 4 - Retirement Eligibility

- To be eligible for Reserve retirement, you must meet the following requirements:

- Complete 20 years of satisfactory service by earning at least 50 points a year, which includes membership points

- To be eligible for an Active Duty Retirement, you must meet the following requirements:

- 20 years of total active federal military service (TAFMS)
- Officers who wish to retire in their officer grade must have 10 years of total active federal service (TAFCS)

- If you have less than 20 years of satisfactory service:

- You must continue to participate until you meet these requirements

- Qualifying for Retired Pay at Age 60:

- To be eligible for retired pay at age 60, one of the requirements is that you complete 20 years of satisfactory service. For each full year of satisfactory service you must earn at least 50 points, including points. If you have accrued 19 years and any number of months and days of satisfactory service remain in a participating status until you have reached 20 full years of satisfactory service, you must complete a partial year of satisfactory service. However, you must earn a prorated portion minimum, including membership points.
- Example: You have 19 years 11 months and 23 days of satisfactory service as of 14 January 2010. 20 years of satisfactory service you would need 7 days. Prorated membership points for service would be zero, however, the minimum points required to receive credit for 7 days of service is 1 point. This point can be earned either by active duty or inactive duty. Your 20th year of satisfactory service would be 21 January 1999 and, your effective date of transfer to the Retired Reserve would be 22 January 1999.

- Categories of Personnel Who Are Not Eligible for Transfer to the Retired Reserve:

- Commissioned officers of the Regular Air Force.
- Members who were administratively discharged for cause.
- Personnel who elected discharge or resigned their commission in lieu of transfer to the Retired Reserve (former members).

Section 6 - Prior to Choosing an Effective Retirement Date

- You need to consider your retirement effective date carefully before completing this application for retirement.

Requests for changes/cancellation of a retirement should not be taken lightly. Retirement effective date or cancellation of your retirement request you application.

- A withdrawal, cancellation or change in a retirement effective date is initial justification, through the appropriate chain of command. The request must be signed by the Program Manager for IMAs that coordinated off on the or with appropriate justification and endorsements, is forwarded through the (TFSC) via this application to HQ ARPC/DPTR for approval. All requests must be effective date.

- If you request to withdraw, cancel or change a retirement effective date v retirement date, you will need to submit a "New Support Request" outside Instructions to request a withdrawal, cancellation or change of retirement provided within the application.

Requests received after the effective date cannot be worked without SAF or the requests must include sufficient justification with appropriate written documents taking final action (i.e., approving request or forwarding recommendation to the obtain a legal review from HQ ARPC/JA).

Section 7 - Choosing an Effective Retirement Date

- For Active Guard Reserve (AGR) applying for retirement you may apply for retirement no later than 1 year from the desired retirement date, but no less than 120 days before your requested retirement effective date (this applies to both a Reserve or Active Duty retirement).

Note:

For an Active Duty retirement, you should allow at least 4 months, including the desired amount of terminal leave and Permissive Temporary Duty (PTDY), for processing your application and issuing orders. (EXAMPLE: If your requested retirement date is 1 July, and you want 30 days of terminal leave and 20 days PTDY, you will submit your application no later than 11 Jan.) Otherwise, you might not receive your retirement orders before the date you are scheduled to depart on terminal leave. Your commander must authorize terminal leave. Approval is not automatic. You may not request a retirement extension nor withdraw your application solely to take terminal leave. Enlisted members must ask for a retirement date that falls within their current enlistment or extension of enlistment.

For a Reserve retirement, you may not be authorized to take PTDY or terminal leave in conjunction with a reserve retirement. You should plan on using your personal leave prior to your retirement effective date. Please coordinate this with your supervisor.

- Officers with 20 years of active service who wish to retire before completing required years of active commissioned service must retire in enlisted status. [AFI 36-3207](#), Separating Commissioned Officers, [AFI 36-2002](#), Regular Air Force and Special Category Accessions, for requesting separation in order to enlist in the Regular Air Force for the purpose of retirement.
- If you are an Air National Guard member in a "Traditional" status or a Military Technician, you must submit your request no earlier than 1 year yet no later than 6 months prior to the requested effective date.
- If you are a Traditional Reservist, Air Reserve Technician or an IM, your effective date of retirement must be at least 6 months but no later than 1 year from your date of application for retirement. You may request a waiver to have a retirement effective date that is earlier than 6 months from your application for retirement. If you desire a waiver, your request for waiver must be submitted with your application.
- If you are an Individual Ready Reserve (IRR) or Standby, application for retirement can be submitted at any time.
- For Air Reserve Component (ARC) members who must be separated for maximum age, **Mandatory Separation Date (MSD)** for officers or enlisted **High Year Tenure Date (HYTD)** (AFR only), or those ARC officers twice deferred for promotion will automatically be transferred to the retired reserve, if qualified, unless the member applies to be discharged or wants to retire prior to their MSD or HYTD.
- Ensure you have contacted the reenlistment/extension Office of Primary Responsibility (OPR) if the need of an extension to your current enlistment. If an unspecified period of time is required, conditional on transfer to the Retired Reserve.

ANG Only: ANG members within 12 to 6 months of their Expiration Term of Service (ETS): You must establish your "Retirement Effective Date" as the same date as your ETS date. ARPC will place you in the Retired Reserves on the date of your ETS. Your date of separation from the ANG will be established as the date prior to your ETS. Example: I'm applying for retirement, the current date is 10 Jan 2010, my ETS is 30 Oct 2010. My requested "Retirement Effective Date" will be 30 Oct 2010. My Date of Separation from the ANG will be 29 Oct 2010.

Retirement Application

The next step in the online retirement process is to complete and submit a Retirement Application. Before your Retirement Application routes to the Air Reserve Personnel Center (ARPC) for processing, Air Force Reserve or Air National Guard members MUST coordinate with your Unit and/or Wing Commander (CC); Individual Mobilization Augmentee (IMA) members MUST coordinate with your Program Manager. NOTE: The system will automatically delete an incomplete application after one (1) year of your 60th birthday.

Active Duty Pay
Members applying for Active Duty pay must complete a Data for Payment of Retired Personnel (DD Form 2656). This form collects information needed to establish a retired/retainer pay account, designate beneficiaries for Survivor Benefit Plan electors, determine Federal tax withholding and establish payee address information.

To apply for Active Duty pay:
1. Complete a DD Form 2656. There is a link to a blank DD Form 2656 (and instructions) within the Retirements Application
2. Upload the completed DD Form 2656 to your Retirement Application. Use the required attachments field at the end of the Retirement Application to upload your completed DD Form 2656

Tips and General Information:
- If the member elects to retire on their MSD then the retirement application is sent directly to ARPC
- Read the instructions and Privacy Act Statement carefully before completing the DD Form 2656
- Complete Section II - Direct Deposit/Electronic Fund Transfer Information. This section MUST be completed as your net retired/retainer pay must be sent to your financial institution by direct deposit/electronic fund transfer (DD/EFT)
- Provide the Routing Transit Number (RTN) and account number of your financial institution
- Consider and elect your Options for the Survivor Benefit Plan (SBP)
- Advise the Defense Finance and Accounting Service (DFAS)-Cleveland of any changes to your marital/family status, address or banking/financial institution/direct deposit information
